2018 AfriScoN International Conference Call for Papers

Theme

Knowledge loss, bondage and regrets in post-contact societies

Venue

Faculty of arts, University of Nigeria, Nsukka

9-13 December 2018

Scholarly discussions around the experiences of most post-contact societies are encountered through theoretically and methodologically radical works such as found within the purview of postcolonial studies. We get a sense of the particularities and the universals in how colonial legacies are experienced and challenged. Yet, we must acknowledge the persistent domination of received over the indigenous knowledges in Africa for instance. In the Africanity Scholars inaugural conference, we ask how one might conceptualise loss, bondage, and regret in thinking about the tensions between autochthonous and heterochthonous knowledge systems. How do religion, technology, culture, society, disciplinary formations, academic discourses, etc. structure and simultaneously play as the sites of these tensions? Papers are invited from academics, scholars, practitioners and advocates of indigenous knowledge systems and graduate students whose research interests relate to these questions. Paper presenters can address the following and any other related themes:
