# **Journal Aims and Scope**

African Journal of Policy Studies and Research (AJPSR), published annually by the Prof. B. I. C. Ijomah Centre for Policy Studies and Research, is a multi-disciplinary journal devoted to original research in the fields of anthropology, economics, development and postcolonial studies, education, environmental studies, history, information sciences, public policy and sociology. It welcomes articles that combine theoretical rigor with empirical information. Innovative opinion pieces are also welcome. Papers to be assessed for publication should include a section arguing for the policy implications of the subject matter under discussion.

## **Manuscript Submission**

Book reviews should be addressed to the Editor for onward transmission to specialized readers. Authors are not paid for their articles. Full responsibility for accuracy of information given in an article is the author's. Authors of accepted manuscripts will be required to send a brief bio of not more than 100 words to be included in the publication.

#### **Editorial Policy**

All submitted manuscripts are double-blind peer-reviewed. Authors are to expect to receive two review reports and a letter of recommendation from the Editorial desk within six months of submission.

For the meantime the journal will be online only.

#### **Instructions for Authors**

AJPSR allows for authorship to be limited to those who contributed significantly to the conception, design, execution, or interpretation of the manuscript.

Submission of a manuscript implies that the work described has not been published previously (except in the form of an abstract or as part of a published lecture or academic thesis or as an electronic preprint).

### Language

Texts are to be written in clear English. Simple, but not simplistic, language is preferred. Only British English is accepted.

## **Plagiarism Policy**

The journal will not accept for review any paper whose similarity index (detected by plagiarism check tools) is more than 15 percent. The author will bear responsibility for any cases of plagiarism. If plagiarism is detected and confirmed by Editorial Staff of *AJPSR*, even after publication of a paper, the paper's publication shall be canceled. It will be ejected from the *AJPSR*'s information system. The author and/or her/his institution will be informed.

### **Title Page**

Submitted manuscript should include the title page with authors' title(s), full name(s) and affiliation(s) as well as corresponding author's contact information. The abstract, which should be on second page of manuscript, and which must not exceed 250 words, will give summary of the paper – background/statement of the problem, methods, results/discussion and conclusion.

References should be with Chicago Manual End Notes format.
