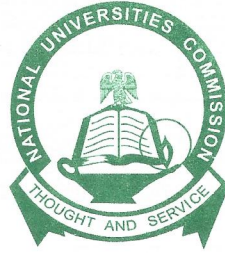


You are requested to please note the implications of the resource verification and accreditation status earned by postgraduate academic programmes of Nigerian Universities are as follows:

- a) All programmes shall bear only the **approved** titles and nomenclature and any change will require the approval of the Commission. The University is enjoined to provide adequate human and material resources for the development and growth of the approved programmes.
- b) **Accredited** status is valid for a period of 5years;
- c) **Not Accredited** status has the following implications:
 - i) Immediate ban on student admission into such programmes;
 - ii) Certificates issued to students admitted into such programmes after the ban on admission, will not be recognised. (Students currently enrolled on the programme will not be affected).
 - iii) The re-visitation to programmes that earned **Not Accredited** status is strictly on University's request.

Attached are details of the technical report(s) for the programme(s).
